**Joyce Batcheller ('05)** will receive her Doctor of Nursing Practice degree from the Texas Tech University Health Sciences Center Anita Thigpen School of Nursing in Lubbock, TX this month. Her capstone project was New Chief Nursing Officer On-boarding and Enculturation: A Case Study.

**Carla Baumann ('04)** received the "Outstanding Public Health Nurse of the Year" award from the Kentucky Public Health Association for work related to establishing and piloting a Regional Training Academy and nurse leadership/mentoring program for Kentucky Department for Public Health in March 2010.

**Bonnie Brueshoff ('06)** has been selected as a Fellow in the National Association of City and County Health Officials (NACCHO) program "Survive and Thrive: Roadmap for New Local Health Officials". This is the second year NACCHO has offered this program geared for Public Health Directors who have been in their position for two years or less. Twenty-four new Local Health Officials were selected for the 2010-2011 period representing 15 states and various types of communities, large and small. Bonnie begins the 12 month program in May.
